



**Electronic Bingo Support**

Voters across the state of Texas clearly feel that reservations should be allowed to offer electronic bingo games to the public. Voters believe that offering these games benefits the state’s economy. In addition, a majority of likely voters object to the state shutting down electronic bingo gaming on reservations.


<sup>3</sup> Question Asked: Would you oppose or support the state of Texas closing the electronic bingo games in the state of Texas?



## Continued Operations

Opposition to the state shutting down electronic bingo gaming is in line with voter support (65%) for legislation that would ensure reservations are able to continue operating on their lands. This support is found across the entire state of Texas and is not dependent on party affiliation.

*Question Asked: As you may know, there is a bill in Congress that would allow all three federally recognized Indian Tribes in Texas to continue to operate electronic bingo games on their reservations. Do you support or oppose this bill?*




## Member Of Congress Voting Against Bill

A plurality of voters indicated they would be less likely to vote for their member of Congress if they opposed reservations' ability to operate electronic bingo games.

*Question Asked: If your member of Congress voted against this bill to allow Texas Indian Tribes to continue to operate electronic bingo games, would that make you less likely or more likely to re-elect them?*

## Methodology

On behalf of the Alabama Coushatta Tribe of Texas, Ragnar Research conducted a survey where interviews were conducted April 28 through April 30, 2019 by telephone, including landlines (22%) and cell phones (78%). Interviews include 1,000 Likely Voters (LVs) across Texas. Quotas on age, gender, ethnicity, education and region were used to ensure a representative distribution. The study's margin of error is ±3%.

## Chris Perkins Bio
